Benefits

Along with the piece-of-mind you get in registering with the database, additional benefits include:

- **Theft deterrent decals** - Even if a thief removes the decal, your equipment is still registered and the thief knows this.
- **Recovery** - NER will be able to identify you as the owner of a registered piece of equipment, increasing the chances that your machine will be identified and recovered.
- **Theft Reporting** - As soon as you notify NER about stolen equipment a full loss report is added to the NER database, ensuring the speed and accuracy of the report that will increase the likelihood of recovery.
- **Risk Management** - Registration helps to control the cost of risk and allows for quicker recovery.
- **Deductible waivers** - Some insurance companies offer up to a \$10,000 deductible waiver for equipment registered with NER. (Please contact Parker, Smith & Feek to see if your policy is eligible)

You also get the support of NER in the form of:

- Online and telephone operator searches of the database.
- Teams of investigators.
- Theft deterrent stickers for registered equipment.
- Claims management

Fees

When registering your equipment you will receive a 20% Parker, Smith & Feek discount.

Lifetime Registration

To register a piece of equipment on the HELPtech® database for as long as you own the unit, costs only \$32.00 (Normally \$40.00). Two warning decals are provided with each registration.

Annual Fee

For owners with large fleets, an annual fee option is available.

The annual fee allows you to add or remove machines as they are purchased or sold. The fee only applies to the total number of registered units, not how many are added or removed throughout the year.
