### NER Stolen Equipment Alert Leads to Recovery

On March, 30, 2012, Herzog Contracting Corp. discovered that their 2004 Sullair air compressor was missing from a jobsite in San Diego, California. Herzog, a long time HELPtech member, notified NER of the theft. NER immediately issued a theft alert and distributed it to law enforcement in California and neighboring states.

Three days later, Investigator Ferdie Aleta of the California Highway Patrol Border Division noticed a Sullair air compressor entering Mexico from California. Investigator Aleta recognized the brand of the compressor from an NER stolen equipment alert that he received a few days earlier. Investigator Aleta contacted NER to receive further details about the air compressor and discovered that the machine he intercepted was the subject of the alert. Investigator Aleta confiscated the compressor and returned it to Herzog.

Vice President of Corporate Equipment at Herzog, Dan Samford, remarked "Thanks to NER and our sharp U.S. Border Patrol officials for the catch." NER encourages contractors to register their equipment with HELPtech as a means to both increase the chances of a theft recovery as well as deter theft.
